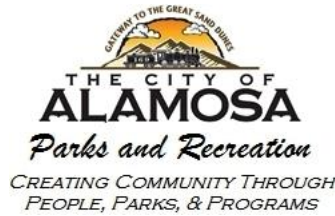

Alamosa Parks & Recreation - Waiver and Code of Conduct Agreement

Waiver: In consideration of your accepting the entries on this form, I hereby, for myself and/or my listed minor children, waive and release any and all rights and claims for damages I or my minor children may have against the City of Alamosa and its representatives, employees, successors for any and all injuries suffered by myself or my minor children at the designated activities sponsored by the Alamosa Parks & Recreation Department. I acknowledge that I may be videotaped, audio recorded, and/or photographed during City of Alamosa activities, and City of Alamosa staff and partners may use and modify the images and/or recordings for any and all uses, including but not limited to advertisements and marketing without any compensation and in perpetuity.

Code of Conduct as a Participant of Adult Activities:

- I will promote sportsmanship and conduct myself in a professional manner during all activities, treating all teammates, opponents, coaches, and recreation staff with respect.
- I will play the game according to the rules and not cheat to get ahead.
- I will not possess, consume, or be under the influence of drugs, tobacco, and/or alcohol during activities.

Consequences for violating Code of Conduct include but are not limited to:

- Verbal and/or written warning
- Ejection from participation and/or coaching
- Suspension from participation and/or coaching
- Lifetime ban from participation and/or coaching
- Subject to prosecution under the law

Code of Conduct as a Parent/Spectator of Youth Activities:

- I will provide positive support and encouragement for all players, coaches, and recreation staff when attending youth program activities.
- I will encourage my child to show good sportsmanship at all games, practices, and events.
- I will place the emotional and physical well-being of participants ahead of any desire to win.
- I will demand a sports environment that is free of drugs, tobacco, and alcohol and will refrain from their use at youth sports events.
- I will insist that events be safe and healthy, as well as do my best to make youth sports fun for my child.
- I will not be involved with any altercations (verbal or physical) with any other parents, spectators, coaches and/or recreation staff.
- I will not coach or yell instructions at players, coaches, or recreation staff from the sidelines.

Consequences for violating Code of Conduct include but are not limited to:

- Verbal and/or written warning
- Removal and/or suspension from a location
- Further suspension from activities
- Subject to prosecution under the law
